Sealed tenders were invited from empanelled vendors for above supply vide letter no Ref. No. BIRD.LKO/ DPSP/P-5/26592/ 2019-20 dated 14 February 2020. 06. All the vendors/prospective bidders are advised to read the Tender document carefully and comply and submit the necessary documents as indicated in the Tender document.
