Sealed tenders are invited from empaneled contractors for **Installation & Testing of Fountain at Bankers Institute of Rural Development, Lucknow** which is estimated to cost **Rs. 5.00 lakh** and to be completed within **45 days** from 10th day of date of issue of work order.

1. Tenders in prescribed format along with Earnest Money Deposit (EMD) of **Rs. 10,000.00 should** be received at Bankers Institute of Rural Development, Lucknow up to **14:00 hours on 16 August 2022. The received tenders may be opened** on the same day at **15:00** hours. Authorized representatives of the submitted tenders should be present. BIRD reserves the right to accept the lowest or any tender in part or full or to reject all of them without assigning any reason. Validity of tendered rates shall be for 90 (Ninety) days from the date of opening of price bid.
2. Applicants are advised to submit their tenders only in the prescribed format which can be downloaded from our website <https://birdlucknow.nabard.org/tender-and-adv/>. Tenders submitted in any other mode will be summarily rejected.
3. Properly filled tender shall be submitted in a sealed envelope duly furnishing all the required information. Envelope should super-scribed as **“Installation & Testing of Fountain”** and addressed to “Director, Bankers Institute of Rural Development, Sector-H, LDA Colony, Lucknow” so as to reach this office **latest by 14:00 hours on 16.08.2022** The tenders should be submitted in ‘Original’ to Bankers Institute of Rural Development.
4. EMD may be paid directly by crediting to BIRD’s Current Account Number- 921020044058630 maintained with Axis Bank Main Branch MG Road, Lucknow, 226001 (IFSC Code- UTIB0000053). EMD has to be deposited only through online mode and no other means including Bank guarantee shall be accepted.
5. Tender may be opened at **15:00 hours on 16.08.2022**. Authorised representatives of the submitted tenders should be present.

6. The tenders will be accepted only in respect of those empanelled bidders whose tenders are in line with the requirements as per the conditions of this document and if the same is acceptable to BIRD. The decision of BIRD in this regard shall be binding on the bidders and not open to questions or appeals.
7. Tenders received after the prescribed date & time, on account of any reason whatsoever as also emailed tenders, shall not be considered.
8. Bankers Institute of Rural Development reserves the right to accept any or reject all the applications without assigning any reason thereof.

2. आवेदकों को सलाह दी जाती है कि वे हमारी वेबसाइट <https://birdlucknow.nabard.org/tender-and-adv/> से प्रपत्र डाउनलोड कर अपनी निविदाएं जमा करें।

3. उचित रूप से भरी गई निविदा एक सीलबंद लिफाफे में विधिवत सभी आवश्यक जानकारी के साथ प्रस्तुत की जाएगी। लिफाफा के ऊपर फव्वारा के निर्माण व परीक्षण हेतु लिखा होना चाहिए और “निदेशक, बैंकर ग्रामीण विकास संस्थान, सेक्टर-एच, एलडीए कॉलोनी, लखनऊ” को संबोधित किया जाना चाहिए ताकि इस कार्यालय में अधिकतम दिनांक 16 अगस्त 2022 को 14:00 बजे तक पहुंच सकें। निविदाएं ‘मूल’ में बैंकर ग्रामीण विकास संस्थान में प्रस्तुत की जाएंगी। बोलियों को सीलबंद लिफाफों में जमा करना होगा और प्रत्येक पृष्ठ पर हस्ताक्षर और मुहर लगानी होगी।

5. निविदा 16.08.2022 को 15:00 बजे खोली जा सकती है। प्रस्तुत निविदादाताओं के अधिकृत प्रतिनिधि उपस्थित रहें।

Terms and Conditions

1. Quotation should be submitted duly signed with date in the enclosed blank proforma of the schedule of items. Rates should be quoted both in figures and words. Violation of this condition may lead to rejection of the quotation.
2. Quotation should be sent in sealed cover, which should be superscripted with the word “QUOTATION” and “ For Installation & Testing of Fountain”.
3. Quotation shall remain valid for a period of three months from the date of opening the same. The rates shall be firm till the completion of the work and no escalation on any account will be allowed.
4. The rates should be inclusive of all relevant transportation charges etc. and for all the accessories required for the completion of the work. No extra amount will be paid for whatsoever. All fluctuations in prices of all materials & labour shall be borne by the contractor. The quoted rate shall be inclusive of GST.
5. Applicant shall quote the rate after carefully observing the site condition and nature of work and quote accordingly. Payment shall be made as per actual measurement. No extra payment shall be done over and above quoted unit rate.
6. The BIRD does not bind itself to accept the lowest or any quotation.
7. The contractors shall examine the site and should thoroughly acquaint themselves with the nature of the work to be done, working conditions, period of permissible execution of the works.
8. Contractors should arrange for the necessary materials required for carrying out the work, including transportation, loading, unloading, payment of all taxes, duties etc. levied by the Government or local bodies.
9. During execution of the work any damage to the property of BIRD is to be rectified by the contractors as per the directions of the BIRD or otherwise BIRD may get the same rectified at the risk and cost of the contractors.
10. The work will be carried out as per the BIRD’s enclosed specifications and conditions of the contract, as provided in the quotation documents which may be inspected at every stage.
11. The works shall be normally carried out during working hours. However, if required to be done after office hours, prior permission may be obtained for working after working hours/holidays and Sundays without causing any disturbance to the occupants.
12. Water will be provided by BIRD free of cost at one point. The contractor should have to make his own arrangements at his cost to take supply lines where ever required with GI pipes, flexible pipes, storage tanks, fixtures etc.
13. Electricity shall be supplied by BIRD free of cost at one point from where the contractor shall make his own arrangements to take supply line where ever required through cables, wires, switch gear, etc.
14. **Completion time:** The work shall be completed within 45 days from 10th day of the date of issue of work order. No extension time will be allowed, except for conditions considered by BIRD’s Authorities to be beyond the control of the Contractor on receipt of written application from him at least three days before expiry date, otherwise clause 16 may be automatically enforced and binding on him.

15. **Defects Liability Period:** 12 months shall be the defects liability period from the date of virtual completion of work.
16. **Liquidated Damages:** If the contractor fails to complete the works by the date stated or within any extended time, the contractor shall pay or allow the employer to recover a sum of Rs. 80/day subject to the ceiling of 10 % of the agreed value as liquidated damages for the period during which the said work shall so remain incomplete and employer may deduct such damages from any money due to the contractor.
17. **Retention Money Deposit (RMD):** A security for the due fulfilment of the contract by the contractor, 5% of the value of work done will be deducted from each payment. The RMD will be Security Deposit. The security deposit will be released after rectification of the defects pointed out, if any during defects liability period i.e. 12 months after the date of virtual completion of work.
18. **BIS (Bureau Of Indian Standards)** specifications should be followed wherever applicable.
19. Payment terms: The first & final bill be paid on satisfactory completion of work done based on actual measurements.
20. In any case of any dispute, the decision of the BIRD shall be final.
21. Failure to observe any of the instructions in clause 1 & 2 may lead to the rejection of the quotation.
22. Safety Code: as per Annexure-A should be observed.
23. The contractor shall abide by and fulfil all requirements laid down under the Contract Labour (Regulations and Abolition) Act, 1970 and the rules framed there-under.
24. Display of notice board: At the site, a display board shall be displayed showing the rates of wages, hours of work, wage period, dates of payment of wages, names and addresses of the Inspectors having Jurisdiction and date of payment of unpaid wages (written in English & Hindi) in terms of provision of para 81(1) of the rules framed under the contract Labour (Regulation and Abolition) Act, 1970.
25. The contractor shall submit to the BIRD the maximum number of Labourers to be engaged on a single day in the job. Any subsequent increase should be informed to the BIRD without delay. If the number of labours employed for the job is twenty or more, the contractor shall obtain the license from the Regional Labour Commissioner.
26. The contractor should ensure payment of minimum wages + VDA to all labours/workmen staff employed by him.
27. The contractor shall maintain all registers as required by the Regional Labour Commissioner and should furnish the same to the BIRD or its representatives as and when required.
28. If the work is not started within 7 days from the date of issue of work order then BIRD may terminate the work order without assigning any reason. If during the execution of the work, the progress of the work is not considered to be satisfactory and is not consistent to be in contingency with the period of the completion of the work then BIRD may terminate the work order by giving a final notice to the contractor.
29. The site of work shall be cleaned and debris shall be removed from the Premises as

and when directed by the BIRD failing which BIRD may remove the debris/surplus material at the risk and cost of the contractor.

30. The Contractor shall not disclose directly or indirectly any information, materials and details of the BIRD's infrastructure/systems/equipment etc., which may come to the possession or knowledge of the Contractor during the course of discharging its contractual obligations in connection with this agreement, to any third party and shall at all times hold the same in strictest confidence. The Contractor shall indemnify the BIRD for any loss suffered by the BIRD as result of disclosure of any confidential information. Failure to observe the above shall be treated as breach of contract on part of the Contractor and BIRD shall be entitled to claim damages and pursue legal remedies.
31. Dispute of any shall be resolved with mutual discussion failing to which the matter shall be returned to arbitration as per Arbitration and conciliation Act (as decided from time to time)

ANNEXURE – A

SAFETY CODE

1. First aid appliances including adequate supply of sterilized dressing and cotton wool shall be kept in a readily accessible place.
2. An injured person shall be taken to a public hospital without loss of time, in cases where the injury necessitates hospitalization.
3. Suitable and strong scaffolds should be provided for workmen for all works that cannot safely be done from ground.
4. No portable single ladder shall be over 8 meters in length. The width between the side rails shall not be less than 30 cm (clear) and the distance between the two adjacent rungs shall not be more than 30 cm. When a ladder is used an extra mazdoor shall be engaged for holding the ladder.
5. The excavated material shall not be placed within 1.5 meters of the edge of trench or half of the depth of trench whichever is more. All trenches and excavations shall be provided with necessary fencing and lighting.
6. Every opening in the floor of a building or in a working platform be provided with suitable means to prevent the fall of persons or materials by providing suitable fencing or railing whose minimum height shall be one metre.
7. No floor, roof or other part of the structure shall be so overloaded with debris or materials as to render it unsafe.
8. Workers employed on mixing and handling material such as asphalt, cement mortar or concrete and lime mortar shall be provided with protective footwear and rubber hand gloves.
9. Those engage in welding works shall be provided with welder's protective eye-shields and gloves. And all engaged labours shall be provided helmets.
10. No paint containing lead or lead products shall be used except in the form of paste or readymade paint.
11. Suitable facemasks should be supplied for use by the workers when the paint is applied in the form spray or surface having lead paint dry rubbed and scrapped.
12. Overalls shall be supplied by the Contractor to the painters and adequate facilities shall be provided to enable the working painters to wash during the periods of cessation of work.
13. Hoisting machines and tackle used in the works, including their attachments, anchorage and supports shall be in perfect condition.
14. The ropes used in hoisting or lowering material or as a means of suspension shall be of durable quality and adequate strength and free from defects.

PREAMBLE TO SCHEDULE OF QUANTITIES

Name of Work: Installation & Testing of fountain at BIRD-Lucknow

The quoted rate shall include the following:-

1. The item and quantities indicated in the schedule of quantity are tentative and as per need of work and as decided by BIRD certain items/quantities may not be required to be executed or may be executed with reduction in quantities to any extent. The contractor has to execute items/quantities as per direction of BIRD and no claim on this account whatsoever it may will be entertained by BIRD in respect of non-operation of items/reduction in quantities.
2. Providing for all costs and charges incurred by the contractor complying with all safety, health and welfare regulations, appertaining to staff and work people employed on the site.
3. Keeping the site free from debris arising from the works during the Installation & Testing/repair period, and leave the site free from debris on completion of work to the satisfaction of the BIRD.
4. Providing electric lights, maintain system, all as required for the works and remove the temporary installations on completion.
5. Charges for inspecting the site and get acquainted with pertaining works just idea for works to be carried out before quoting the rates.
